1. Rules:

This Regatta will be governed by the rules as defined in the Racing Rules of Sailing 2009-2012 and the current SCIRA Class Rules. In case of conflict between the Notice of Race and the Sailing Instruction the Sailing Instructions shall prevail.

2. Eligibility and Entry:

3. Fees: \$55

Entry fee includes: lunch Saturday and Sunday, dinner Saturday night, trophies.

12:30 Warning signal for the first race, additional races to immediately follow.

10:30 Warning signal for the first race, additional races to immediately follow.

No race will be started after 15:00

Awards ceremony will be held as soon as practical after the last race, at the USC clubhouse.

5. Sailing Instructions:

Sailing instructions will be available at registration.

6. Regatta Site:

The regatta site will be at Union Sailing Club on the South Eastern Shore of Union Reservoir, Longmont, Colorado. **NOTE: Only launching by hand or by hand-dolly is allowed at USC (dollies are available for use at USC).** Trailer launching is available at the public launch ramp at the South West end of the lake.
